

# Life Membership Nomination Form



## Information Sheet and Nomination Form

Life Membership is a prestigious award to members who have given outstanding service to netball at the State level.

It is the highest award Netball Victoria can give to someone for their contribution to the promotion and development of Netball in Victoria. Life Members will have developed initiatives and had a significant impact on making change.

### Nominations

Nominations are to be made on this form, giving the details of the person nominated and detailed reasons for the nomination. Nominations must be made and seconded by current Netball Victoria members. Nominations for consideration by the Board must be received by the Chief Executive Officer **no later than the last working day in November** in each calendar year.

### Guidelines for Nominations

1. Any member of Netball Victoria may nominate another member.
2. Nominations must be made on the official form and should be typed or clearly printed in bold letters.
3. The Life Membership nominee must have demonstrated an outstanding contribution to the overall development of Netball in Victoria. The nominee must be a volunteer.
4. Detailed reasons must be included by the nominators stating why the nominee should be considered for Life Membership. This information should explain how the individual has made an outstanding contribution to netball at State level.
5. It is helpful to include examples that best show how the nominee has gone above and beyond what could be reasonably expected of someone in a similar position. It may include references to:
  - a. General achievements which have had a positive effect at State level.
  - b. Specific initiatives which have had a significant impact on making change at the relevant level.
  - c. Achievements that have demonstrated the nominee to be an outstanding person, e.g. Leadership, Management / Administration and Development (Junior, Umpiring, Coaching, Facilities etc).
  - d. Voluntary work for netball over a verifiable period of time.
  - e. Commitment of the individual.
6. Where relevant, dates should be given for specific achievements and evidence of these provided by way of written references and other relevant supporting documentation, i.e. newspaper clippings, certificates, awards etc. These documents must be legible and authentic, or able to be confirmed as such.
7. Nominations and supporting documentation, once submitted, become the property of Netball Victoria and will not be returned.
8. Nominations submitted to Netball Victoria will be researched for eligibility by the organisation's archivist and / or appropriate personnel and the nomination profile will be compiled. The research process could include an interview with the nominee in order to assist with accuracy and completion of the nomination.
9. Nominations must be signed by two current Netball Victoria members, neither of whom is related to the nominee or each other.
10. The Netball Victoria Board will view all nominations and select award recipients. The Board makes the decision to grant awards and there is no appeal against the decision.
11. All nominations will be treated confidentially.
